

ORDINANCE NO. 13- 2013

AN ORDINANCE PROVIDING FOR THE PARTIAL AMENDMENT, SUPPLEMENTATION AND REPEAL OF CERTAIN FEES SET FORTH IN THE FEE SCHEDULE OF THE BOROUGH OF MORRIS PLAINS, CHAPTER 2, SECTION 2-46 AND FOR THE REPEAL OF PARAGRAPH (e) IN CHAPTER 22, SECTION 22-28 IN THE "REVISED ORDINANCES OF THE BOROUGH OF MORRIS PLAINS, NEW JERSEY, 1972".

**WHEREAS**, municipalities are permitted to fix fees as prescribed by law or, under N.J.S.A. 40:48-1(4), for any service rendered by any officer or employee of the municipality in connection with his office or position, for which no specific fee is provided; and

**WHEREAS**, Chapter 2, Section 2-46, entitled "FEE SCHEDULE," of the Revised Ordinances provides that the Borough Council shall update and amend the Fee Schedule as needed; and

**WHEREAS**, the Borough Council is desirous of amending Chapter 2, Section 2-46 to amend certain fees, all as set forth in the Fee Schedule; and

**WHEREAS**, the Borough Council has received the recommendation of the Traffic Safety Committee of the Borough of Morris Plains recommending the repeal of a certain regulation governing parking in the municipal parking lots; and

**WHEREAS**, the Borough Council is desirous of amending Chapter 22 consistent with the recommendation of the Traffic Safety Committee.

**NOW, THEREFORE, BE IT ORDAINED**, by the Borough Council of the Borough of Morris Plains, they being the Governing Body thereof, as follows:

**Section 1:**

The FEE SCHEDULE of the Borough of Morris Plains set forth in Chapter 2, Section 2-46 of the aforesaid Revised Ordinances is hereby supplemented and revised with the repeal of the following fees:

**Section 2:**

The FEE SCHEDULE of the Borough of Morris Plains set forth in Chapter 2, Section 2-46 of the aforesaid Revised Ordinances is hereby amended and supplemented with the following increased fees:

**Section 3:**

Section 22-28, "Unlawful parking," as set forth in Chapter 22 of the Revision is hereby amended, supplemented and revised with the repeal of paragraph (e), which presently reads as follows:

(e) No person shall park any vehicle in a properly designated parking space except by driving the vehicle forward in to the space and not by backing the vehicle into the space.

**Section 4:**

All other provisions of the aforesaid FEE SCHEDULE, Section 2-46, Chapter 2 and Section 22-28, Chapter 22 of the Revised Ordinances shall be unaffected and are hereby continued.

**Section 5:**

All Ordinances and parts of Ordinances inconsistent herewith are hereby repealed to the extent of such inconsistency.

**Section 6:**

If any section, subsection, sentence, clause or phrase of this Ordinance is, for any reason, held to be invalid by a Court of competent jurisdiction, such a decision shall not affect the validity of the remaining portions of this Ordinance.

**Section 7:**

This Ordinance shall take effect immediately after final passage and publication.
