- Forms are kept on file for two (2) years.
- Borough of Morris Plains employees may not serve on Borough of Morris Plains boards or commissions except as specifically provided by the statute or regulation, or by the Borough Code, as required to perform official duties.
- IN ACCORDANCE WITH LOCAL GOVERNMENT ETHICS LAW, [N.J.S.A. 40A:9-22.6](#), a Financial Disclosure Statement is required to be filled annually by (i) elected officials; (ii) certain government employees; and (iii) individuals serving on a local government agency which have the authority to levy taxes, enact ordinances, approve development applications or grant zoning variances. The Borough Clerk will notify such individuals each year when their Financial Disclosure Statement must be completed and filed with the State of New Jersey.
