ORDINANCE NO. 11-2022

AN ORDINANCE AMENDING CHAPTER 22, TRAFFIC AND PARKING, SECTION 22-4 ENTITLED ONE-WAY STREETS DESIGNATED OF THE "REVISED ORDINANCES OF THE BOROUGH OF MORRIS PLAINS, NEW JERSEY, 1972" TO INCUDE A PORTION OF AMERICAN ROAD.

WHEREAS, JMF at Morris Plains, LLC., is developing property
located at Block 11, Lot 1 in the Borough of Morris Plains; and
WHEREAS, the development that allows for the construction
of a cul-de-sac along American Road; and

WHEREAS, the Borough of Morris Plains is desirous of designating a portion of American Road as one-way for vehicular traffic to prevent traffic from traveling eastward through the cul-de-sac along American Road into Hanover Township.

NOW, THEREFORE, BE IT ORDAINED, by the Borough Council of the Borough of Morris Plains, they being the Governing Body thereof, as follows:

Section 1:

Section 22-4 One-Way Streets Designated in Chapter 22 of the Revision is hereby amended, supplemented and revised by deleting the following language:

The following streets or parts of the streets are hereby designated as one-way streets in the direction indicated:

Allen Place - Northbound, from Morris Plains Avenue to the point where Allen Place turns left toward Speedwell Avenue. Hillview Avenue - Westbound, from Speedwell Avenue to Mountain Way.

Mountain Way - Northbound, from West Hanover Avenue to Rosedale Avenue.

And inserting the following in its place and stead:

The following streets or parts of the streets are

hereby designated as one-way streets in the direction

indicated:

Allen Place - Northbound, from Morris Plains Avenue to the

point where Allen Place turns left toward Speedwell Avenue.

Hillview Avenue - Westbound, from Speedwell Avenue to

Mountain Way.

Mountain Way - Northbound, from West Hanover Avenue to

Rosedale Avenue.

American Road - Westbound, from the border with Hanover

Township for a distance of eighty (80) feet to a proposed

cul-de-sac.

Section 2:

All other provisions of the aforesaid Chapter 18 of the

Revised Ordinances, including but not limited to Section 18-11,

shall be unaffected and are hereby continued.

Section 3:

All Ordinances and parts of Ordinances inconsistent

herewith are hereby repealed to the extent of such inconsistency.

Section 4:

If any section, subsection, sentence, clause or phrase of

this Ordinance is, for any reason, held to be invalid by a Court

of competent jurisdiction, such a decision shall not affect the

validity of the remaining portions of this Ordinance.

Section 5:

This Ordinance shall take effect immediately after final

passage and publication.
